DECIDES:

Article 1. To approve the continued listing post-corporate restructuring and the additional listing of shares for QP Xanh Investment Joint Stock Company with the following details:

- **Securities Name:** Shares of QP Green Investment Joint Stock Company.
- **Type of Shares:** Ordinary shares.
- **Stock Symbol:** HKT.
- **Par Value:** VND 10,000/share.
- **Method of Issuance:** Private placement.
- **Number of Additionally Listed Shares:** 27,200,000 shares (Twenty-seven million two hundred thousand shares).

- **Value of Additionally Listed Shares (at par value):** VND 272,000,000,000 (Two hundred seventy-two billion Vietnamese Dong).
- **Total Number of Listed Shares Post-Restructuring:** 33,335,029 shares (Thirty-three million three hundred thirty-five thousand and twenty-nine shares).
- **Total Value of Listed Shares Post-Restructuring (at par value):** VND 333,350,290,000 (Three hundred thirty-three billion three hundred fifty million two hundred and ninety thousand Vietnamese Dong).

QP Green Investment Joint Stock Company is responsible for disclosing information in accordance with current regulations, registering the trading date for the new shares within 05 working days from the date of this Decision and complying with legal regulations on securities trading activities.
